During this time, he conducted research on deceptive language and developed the Statement Analysis® techniques to determine if a person is lying or telling the truth.

After retiring from the Marshals Service in 2009, Mark started Statement Analysis LLC. His company provides interviewing skills training and assists in analyzing verbal and written statements. Mark has appeared on numerous television shows and podcasts. He is the author of the books *I Know You Are Lying* and *Don't Be Deceived*.
